

NAWC® introduces new credential in ostomy management

Each year, more than 120,000 Americans receive stoma surgery that creates a possible life-long ostomy. Further, it's estimated that between 500,000 and 800,000 men, women, and children live with an ostomy every day. It's a goal of the National Alliance of Wound Care (NAWC) to meet the growing need for more certified experts in ostomy management by introducing a new certification program in the specialty of ostomy management. The credential, Ostomy Management Specialists (OMS), is the fourth wound care—related certification available from NAWC.

"The Ostomy Management Specialist certification program is a huge milestone for us as we can now offer this professional credential not only to our 13,000 wound care certificants, but also to the entire healthcare community," stated NAWC Executive Director, Debbie Hecker, MBA, RN, WCC, DWC. "By expanding our offerings, we are truly leading the wound care industry in this new century. Physicians, therapists, and all nurses can now obtain the tested competency and recognition as specialists in Ostomy Management in order to help their patients and advance their careers."

NAWC introduced this new credential at the annual Wild on Wounds (WOW) Conference in Las Vegas this September as part of NAWC's 10th anniversary celebration.

WCC® recertification: A critical step in your professional development

WCC Recertification

As the largest and fastest-growing

wound care certification, the WCC now

represents more than 13,000 certificants. This means that more professionals are certified as WCC clinicians than as any other wound care credential in the United States. In real numbers, this represents an amazing growth of nearly 2,000 new WCC clinicians each year. As a result of this incredible growth, we are experiencing large numbers of WCC clinicians who must recertify each year. Recertification is an easy, yet necessary process to ensure you maintain your WCC credential.

NAWC requires recertification every 5 years to ensure that you as a WCC clinician are exposed to new clinical advancements and standards of care within the area of skin and wound management. Recertification is a means of providing ongoing assessment of continued competence and professional growth. This assures patients that all clinicians awarded the WCC credential have kept abreast of any new developments and have maintained active continuing education and practice activities to strengthen their knowledge in the area of skin and wound management.

Recertification deadlines

All WCC credentials expire on the last day of the month, 5 years after initial certification. Expiration dates are located on your WCC certificate. You will begin to receive recertification correspondence from NAWC just prior to the beginning of your last year of certification. Applications for recertification are accepted no earlier than 6 months prior to your expiration date and no later than the postmark of your expiration date. Pathways to recertification

NAWC offers four pathways to WCC recertification. Applicants for recertification of the WCC credential must meet all of the following criteria:

- 1. Active unrestricted license as a registered nurse, licensed practical/vocational nurse, nurse practitioner, physical therapist, physical therapy assistant, occupational therapist, or physician or physician assistant
- 2. Current WCC credential (not lapsed)
- 3. Payment of required fees
- 4. Submission of recertification application for one of the following recertification options:
 - a. Examination
 - b. Training (live instruction or online).
 Submit directly to Wound Care Education Institute (WCEI) (www.wcei.net)
 - c. Continuing Education (60 contact hours)
 - d. Continuing Education (30 contact hours) and Outreach Program (CEOP)

Upon successful completion of the recertification process, current WCC clinicians in good standing may continue to use the initials "WCC" to designate their status. Credentials are awarded for a 5-year period. Upon expiration of the credentialing term, WCC clinicians are required to recertify with NAWC to maintain their credentials.
